COLLECTION STATEMENT AND CONSENT

Gladstone Regional Council (“**Council**”) is obliged to comply with the provisions of the Information Privacy Act 2009, Right to Information Act 2009 and the Public Records Act 2002.

2. Give the Council, its employees and those acting with its authorisation the right and permission to copyright, use, and/or publish my photographs and/or the video of the Participant in the Promotional Material.
3. Waive any right to inspect, review or approve the finished videos, photographs, advertising copy, or printed matter prior to them being reproduced or to approve the eventual promotional use they might be applied.
4. Consent to the Participant’s personal information being used for Promotional Material, including but not limited to being published on Council’s website and social media. I acknowledge that these sites will be available outside of Australia and may not be subject to the protection afforded by Australian privacy laws.
5. Agree that no claim will be made against Council for any payment or fee for photographs, video, or audio recordings where the Participant’s images appear in Promotional Material; and
6. Release Council, its officers, employees, and agents from any liability arising out of Council’s use of photographs, video, or audio recordings of the Participant.
